1. KEY OBJECTIVE

The general objective of the Social Justice Incubation Program under SEE Change is to contribute to the local economy and social stability of Lebanon by promoting diversification of incentives for Social Economy and Social Justice advancement, co-identifying with local communities and key stakeholders both the most suitable actors (individuals and organisations) and the optimal environmental factors for a successful and impactful incubation of 20 social economy initiatives in Lebanon.



THE SOCIAL JUSTICE INCUBATION PROGRAM MANIFESTO

This is a call for proposal for those who believe that Lebanon can and must be better, becoming more sustainable, inclusive, equitable and just for all.

The Social Justice Incubation program is for organisations and groups of people who think that collaboration is the key to make this happen, because the problems that we are facing are bigger than any of us and no one can solve them alone.

Everyone of us can be part of the solution, but we need to talk and to listen to each other, to share knowledge, resources and opportunities and to test models of collaboration, projects and initiatives that later on can be replicated or scaled around Lebanon.

The Social Justice Incubation Program has been designed to help organisations to connect and to work together in order to move forward on co-creating and achieving the solutions we all need.

2. BACKGROUND

Lebanon continues to witness multifaceted and intertwined crises, which puts the country and its people in a vulnerable position. The severe economic crisis was compounded with the increasing number of COVID-19 cases being reported starting from September 2020. Furthermore, the explosion that destroyed large neighbourhoods in Beirut, on August 4, 2020, led to the resignation of the government and further social, economic and administrative demise.

Social Economy is increasingly regarded as a tool capable of easing communal tensions and contributing to socio-economic development and to enhance Social Justice. Social Economy organisations have different forms of operating, according to the culture and the model they adopt (social business, social enterprise, entrepreneurial non for profit organisations, benefit corporation, social cooperatives); they works under a human-centred design business model able to overcome any policy fragmentation and to contribute to a systemic change in a sustainable and inclusive way, with strong solidarity values. Social Entrepreneurship responds to the national priorities and its aligned with Lebanon Crisis Response Plan (LCRP) goal, and the strategy of the Livelihood and Social Stability Sector. During the past few years, several projects started promoting Social Entrepreneurship as a tool to strengthen social stability and support local economic development for Lebanese, Palestinian and Syrian refugees.

Despite Lebanon has no legal frameworks for Social Entrepreneurship, the practices on the ground are already existing with a potential that still need to be unlocked.

COSV - in partnership with Beyond Group and OXFAM - is implementing an EU Funded project called "Social Entrepreneurship Ecosystem Change" (SEE Change). The project aims to increasing the impact of social entrepreneurial actives in Lebanon, creating employment and social stability opportunities, and supporting the local economy. Under SEE CHANGE COSV is launching this incubation program to boost the practice of collaborative economy and amplify the potential of new models of Social Entrepreneurship in Lebanon.

COSV (Coordinamento delle Organizzazioni per il Servizio Volontario) is an Italian NGO working in the field of International Cooperation registered in Via Soperga 36, 20127 MILANO (MI), Italy and has been present in Lebanon since 2006. Globally, COSV runs projects on Social Entrepreneurship, Sustainable Development, Health, Water and Sanitation, Education and Food Security. COSV always works in partnership with local CSOs and organisations in order to promote authentic bi-lateral cooperation, tackle local problems, and share experiences and best practices. Specifically, in Lebanon, COSV focuses its activities on Social Justice, Social Entrepreneurship, Environment, Human Rights, Intercultural Dialogue, Culture, Arts and Sustainable Economic Development. Since 2018 COSV has invested in a Social Economy Unit to better deliver technical assistance to all the socio-economic programs. COSV is a member of DIESIS.

3. THE SOCIAL JUSTICE INCUBATION SUB-PROGRAMMES

The Social Justice Incubation Program includes **4 different sub-programmes** that are linked to specific business models:

Community Enterprise incubation sub-program

This program aims to promoting a collaborative economy mechanism led by citizens to solve community problems/gaps. Possible outputs linked to this sub-programme are community enterprises¹ in charge of co-managing community hubs, community-based services, touristic services, urban farming and gardening or other activities based on a more inclusive and efficient way of managing public under-utilised local assets and resources.

¹ Community enterprises can be defined as entities with different legal frameworks like SMEs, NGOs, foundations where founders or shareholders are public, private and/or citizens that intend to improve the community welfare in a specific geographical area

School-Enterprise incubation sub-programme

This programme is dedicated to Vocational Training Institutions (VTIs) and SEs. The sub-program will support mainly the development of a third entity where the main founders are VTI and SEs or other type of partners willing to create a competitive service provider company aiming to serve the local communities with a social entrepreneurial mindset and framework. The new entities aim to be linked but autonomous from the existing education institution and their main objective is to improve the VTI programs with a complementary sustainable alternative to the job placement of young graduates.

NGOs in transition incubation sub-program

This program is dedicated to non-for-profit organisations willing to become a social enterprise or to transit or to strengthen their market-oriented activities with the support of peer organisations, for example applying economy of scale strategies, social franchising, sector-hub entrepreneurship initiative.

PPP incubation sub-program

This program will support mainly municipalities or union of municipalities and organisations willing to pilot the delivery of community-based service under a public social procurement framework.

3.2 Taxonomy

SOCIAL ECONOMY: As we can find in the website of the EC (European Commission) "A significant proportion of Europe's economy is intended to make profits for people other than investors or owners. Known as the 'social economy', it includes cooperatives, mutual societies, non-profit associations, foundations and social enterprises". Also we can define it according to a certain number of structural criteria, "such as its social aims, its participatory and democratic decisional criterion and its profit distributive criterion based on the prevalence of people and labor factor over capital" (Chaves & Monzon, 2018).

SOCIAL JUSTICE: In our case, this concept is to be defined according to Jost (2010) citing three renowned researchers "social justice is a property of social systems — or perhaps a "predicate of societies" (Frankena, 1962) — as suggested also by Rawls (1971) and Toynbee (1976). A just social system is to be contrasted with those systems that foster arbitrary or unnecessary suffering, exploitation, abuse, tyranny, oppression, prejudice, and discrimination."

SOCIAL ENTERPRISE: in our case it includes all four types of models according to ICSEM (Social Cooperative, Public Social Enterprise, Entrepreneurial Non Profit and Social Business).

SOCIAL COOPERATIVE: One of the main types of social enterprise models according to ICSEM. There it is defined as follows "The social cooperative (SC) model differs from traditional mutual-interest organisations—i.e. cooperatives (Coops) and mutual-interest associations (MI-Assoc.)—in that it combines the pursuit of its members' interests (mutual interest) with the pursuit of the interests of the whole community or of a specific group targeted by the social mission (general interest)".

PUBLIC SOCIAL ENTERPRISE: One of the main types of social enterprise models according to ICSEM. There it is defined as follows "The public-sector social enterprise (PSE) model results from a movement towards the marketisation of public services which embraces "public-sector spin-offs". These SEs are usually launched by local public bodies, sometimes in partnership with third-sector organisations, to provide services which are outsourced (such as care services) or new services (such as those offered by WISEs)".

ENTREPRENEURIAL NON PROFIT: One of the main types of social enterprise models according to ICSEM. There it is defined as follows "The entrepreneurial non-profit (ENP)model gathers all non-profit organisations, most often general-interest associations (GI-Assoc.), that are developing any type of earned-income activities in support of their social mission".

SOCIAL BUSINESS: One of the main types of social enterprise models according to ICSEM. There it is defined as follows "The social business (SB)model is rooted in a business model driven by shareholders' (capital) interest, but social businesses mix this logic with a "social entrepreneurial" drive aimed at the creation of a "blended value", in an effort to balance and better integrate economic and social purpose".

SHARED VALUE (INITIATIVE): Also called Creating shared value (CSV), it is a business concept first introduced in 2011 and led by two highly relevant scholars Michael E. Porter and Mark R. Kramer. In 2012, with the support from FSG they created the Shared Value Initiative. There it says "The Shared Value Initiative is a global platform for leaders seeking to solve societal challenges through business solutions and to help companies fulfil a purpose beyond profits alone".

IMPACT ECONOMY/INVESTMENT: Around the concept of Impact there have been a series of initiatives which tend to have in common the inclusion of an specific intentionality (social or environmental) in the economic action of both public and private actors and that this intentionality needs to be measured. Relevant actors in this area are GIIN and GSG.

SHARING ECONOMY: This is a highly contested concept. In order to define it we can use the EESC opinion on this issue: "Rather than a definition, which we will nevertheless seek to provide, it is important to define its characteristics, of which the following stand out:

- it does not result in the ownership or joint ownership of goods, but in pooled use;
- an intermediary platform which is usually electronic to put a significant number people offering goods or services in touch with a significant number of users;
- a common objective to make better use of goods and services by sharing them; and
- The final parties to these complex three-way transactions are primarily peers (P2P) and are never part of a business to customer (B2C) contractual relationship.

These characteristics, supported by a concept that benefits from fairly widespread consensus, make it possible to define the model for this type of economic relations and to distinguish between real sharing economy practices that require special arrangements and those that are sometimes wrongly described as such merely to get around regulations that should apply to them".

SOCIAL PUBLIC PROCUREMENT (or Socially Responsible Public Procurement): It is understood as the use of tendering processes to achieve multiple social goals. Thus, the EC in its Social Procurement website signals "Public authorities can engage in socially-responsible public procurement by buying ethical products and services, and by using public tenders to create job opportunities, decent work, social and professional inclusion and better conditions for disabled and disadvantaged people".

4. WHAT THE SOCIAL JUSTICE INCUBATION PROGRAM SUB-GRANT SCHEME OFFERS

The reserved amount for this call is USD 600.000 under 4 LOTS. COSV has the right to not allocate all the budget available for this action if the applicants do not match the required qualifications.

Applicants can apply ONLY in one of the following four lots:

✓ LOT 1: Community Enterprise amounting to USD 150,000

Noting that the maximum grant request can be:

 USD 20,000 for a consortium of a minimum of two partners applying for this call with a collaborative economy initiative with the potential to become a Social Enterprise.

✓ LOT 2: NGOs in transition amounting to USD 150,000

Noting that the maximum grant request can be:

- USD 20,000 for a consortium of a minimum of two partners applying for this call with a collaborative economy initiative, where one of the partner should be an NGO officially registered in Lebanon.
- ✓ LOT 3: School Enterprise amounting to USD 150,000

Noting that the maximum grant request can be:

- USD 50,000 for a consortium of a minimum of two partners where one of the partner should be a Technical Vocational Institution - applying for this call with a collaborative economy initiative.
- ✓ LOT 4: PPP amounting to USD 150,000

Noting that the maximum grant request can be:

 USD 50,000 for a consortium of a minimum of two partners applying for this call with a collaborative economy initiative that has the potential of becoming a Public Private Partnership recognised under Lebanese Laws.

For each one of the 4 lots it's mandatory to apply as a consortium (with a minimum of 2 parties).

In addition to the financial support:

- selected consortia will receive a one-to-one be-weekly coaching session to support their initiatives and to assist them in the financial reporting procedure.
- selected organisation will collaborate with COSV team in an impact analysis research.

Notice for applicants:

Applying as a consortium is mandatory.

The sub grant-contract will be signed by all the parties, noting that the financial transactions will be transferred to the lead applicant only or to a focal point appointed by a formal agreement between parties.

Co-applicants within a consortium, must provide a **letter of mandate**, authorising the lead applicant to submit the proposal and, if the proposal is accepted for funding, to sign the grant agreement with COSV on their behalf.

The lead applicant headquarter and address should be in Lebanon, the operations and implementation of grant activities should target Lebanon.

6. ELIGIBLE SECTORS

The Social Justice Incubation Program is open to supporting solutions in almost any sector, sub-sector, or market niche. However, preference will be given to applications that support the following sectors:

- Agri-food (Home Farming Services, Organic Production, Diary, Packaging....)
- **Environment** (Renewables, Food oil, Glass recycling, Local Furnitures, Organic food waste management....)
- **Education** (Online Learning: IT, Tools, Learning Measurement, Online Exams, Communication ...)
- **Healthcare** (Mental Health, Residential Developmental Handicap Facilities, Community Care Facilities for The Elderly, Urgent Care Centres, Home Health Care Services ...)
- **Culture** (Creative Industries: Visual Arts, Performing Arts, Heritage, Film, Television, Radio, Music, Books and Press; Design, Architecture and Advertising; Ecotourism, Handcraft, Sewing...)
- **Technology** (E-commerce platforms, Communication, Media, Entertainment, Healthcare technology, business intelligence...)

Note: the Social Justice Incubation Program aims to contribute to the 2030 Agenda² for Sustainable development supported by the United Nations. For this reason we are selecting initiatives able to contribute to the following 17 Sustainable Development Goals (SDGs³):

7. NON ELIGIBLE EXPENSES

SJIP sub grant funds may not be utilised for the following:

- Prohibited goods under Lebanese regulations, including but not limited to: military and surveillance equipment, police or law enforcement equipment, abortion equipment and services, weather modification equipment, luxury goods, and gambling equipment;
- Any purchase or activity, which has already been made prior to the signature date of the sub-grant contract;
- Previous obligations and/or debts;
- Fines and/or penalties;
- In general, costs not included in the approved budget may not be allowed unless approved in writing by the team.

Other non eligible expenses might be specified in the sub grant contract.

8. FINANCIAL AND IN KIND CONTRIBUTION FROM THE APPLICANTS

The Social Justice Incubation Program doesn't require a mandatory co-finance contribution from applicants. However, due to the nature of this program, in the evaluation process, financial and/or inkind contributions from the participants are considered as a plus because they can contribute to the sustainability and feasibility of the initiative proposed.

9. COST REASONABLENESS & ENVIRONMENTAL COMPLIANCE

All grant costs must be reasonable. Value-for-money cost options, that meet the needs of the grant activity, should be used. Costs incurred and activities implemented must be within the normal operating practices of the applicant and in accordance with its written policies and procedures.

Sustainable and local procurement is encouraged, intended as the acquisition of goods, works, services or consultancies whose results have the least possible harmful effects on the environment, human health and safety when compared to other competing and similar acquisitions, or those that make a positive impact on the environment.

10. SUBMISSION DEADLINE

Full application forms must be submitted to COSV on SJIP@cosv.org by April 21st, 2021 - 1 pm Beirut time. Late submissions will not be considered.

Applications must be submitted in **English** or **Arabic**.

11. APPLICATION GUIDELINES

COSV will screen the received applications within the deadline to make sure that **all requested documents⁴ were submitted**. Accordingly, COSV will send a confirmation email informing the applicants that their application will be considered for evaluation.

13. EVALUATION CRITERIA

The Social Justice Incubation Program has been designed to enhance Social Justice within a sustainable socio-entrepreneurial framework and a collaborative mindset. For this reason each proposal will be evaluated under this 3 main criteria:

1. Social Aim/Contribution to Social Justice:

O Relevance of the social aim:

- How the initiative is enhancing social justice
- Clear definition of the beneficiaries of the initiatives

o Coherence:

 Coherence among the social goal, organisation structure and entrepreneurial proposed activity

Social Innovation

- Extent to which the solution is different from the existing ones;
- Innovation potential of then proposed activity

2. Sustainable Entrepreneurship

o Business viability

- Established market demand for the social enterprise product and/or service.
- Clear track record and/or realistic projections;

Cost Effectiveness

 The degree to which budgeting is clear and reasonable and reflects best use of applicant and grant resources;

Team Strength

- Founder's vision and commitment to achieving profit and social impact;
- Management team's experience and ability to achieve the growth targets.

Sustainability

- Contribution to the SDGs
- Sustainability of the initiative after the end of the grant period
- potential of becoming a SE (Social Enterprise)
- Repeatability and/or scalability of the initiative

3. Collaboration framework

- o Collaboration
 - Governance model
 - Coherence on the collaborative management of resources
- Existing Assets and potential partnership
 - Additional financial and/or in-kind resources brought by the co-applicants and partners
 - Additional contributions by other partners
 - Potential stakeholders and future partners

COSV will provide guidance and customised reporting templates to the awarded applicants for their quarters, midterm and final narrative and financial reporting.

COSV will provide a Coach to support each one of the selected initiative and it is mandatory for the consortia parties to participate to monthly knowledge sharing and facilitation sessions during the program.
